National Update

One Big Beautiful Bill Act (OBBBA)



- Signed by the President on July 4, 2025
- Some elements affecting higher education:
 - College programs eligibility for federal student loans dependent on 'earnings test'
 - Implements graduate student loan caps
 - Limits 'parent loan for undergraduate students' (PLUS) loans
 - Eliminates graduate student PLUS loans

One Big Beautiful Bill Act (OBBBA) - 2

- Some elements affecting higher education:
 - Expands Pell program eligibility
 - Funds \$10.5B to Pell
 - Delays borrower defense and closed school discharge rules
 - New income-driven repayment (IDR) plan
 - *timing varies on initiative implementation

FY26 Budget Update



- UBC met 3 times in June to reach balance point between expected revenue and expenses
 - 2 meetings in July
 - July 2 campus-wide update email
- Emphasis on:
 - Enrollment growth
 - Student retention
 - Increasing program margin
 - Online program expansion
 - Executive education & certificates proliferation
 - Non-traditional revenue development

FY26 Budget Update - 2



- Ambitious targets are being set for every area

- UNT budget submitted to System on June 27 for review
 - UNT budget support material to System on July 3
 - Awaiting feedback and/or budget acceptance from System
 - Board of Regents meeting on August 14

January 31, 2025	FY26 Operating Budget Cycle Kick-off; System Administration distributes Consolidated Budget Guidelines
February 3, 2025	Axiom Opens - Initial seed budgets loaded
March (week 1)	System Administration Budget reviewed with CFOs and finalized
June 20, 2025	Axiom Closes - Member Institutions submit final budgets to System Administration
June 27, 2025	Member Institutions submit narratives, presentations, and requested information to System Administration
July (week 1)	Chancellor and DC meet with Presidents and CFOs to review budget materials
July (week 1)	Materials for BOR Finance Committee submitted to board Secretary
July (week 2)	Draft FY26 Budget materials presented to BOR Finance Committee
July (week 3)	Consolidated Budget Book & presentation drafts completed for final review
July 23, 2025	Final board materials due to Board Secretary
August 14-15, 2025	Consolidated Budget approved at BOR meeting

Pausing certain epars in late July/August



Submit epars by 5pm on 7/25/25 All ePARs for reclassifications and market/equity adjustments for filled staff positions must be submitted by 5:00 pm on 7/25. Vacant position reclassifications or salary changes may still be submitted. Reclassification and market/equity adjustments for filled positions received after 7/25 will be denied and may be resubmitted in FY26.

This helps to better manage the end of year processing for the fiscal year rollover and minimize rollover error.
